

## Terms & Conditions

### **These Terms & Conditions are in association with Clan na Gael's End of Year 2021 Fundraiser.**

1. First Prize – The winner will receive a holiday to New York, New York, USA which will include direct flights and hotel accommodation in Manhattan for two people to the value up to €2,500 or an equivalent cash alternative. The duration of the holiday will be 5 days (4 nights).
2. Runner Up Prizes – 2<sup>nd</sup>: 2 Tickets to 2022 All Ireland Football Final and an overnight stay in a 4\* hotel for 2 people. 3<sup>rd</sup>: 2 Tickets to Ed Sheeran at Croke Park April 2022 and an overnight stay in a 4\* hotel for 2 people.
3. Ticket cost €20.
4. The Competition Draw will take place on 26<sup>th</sup> December 2021 in Clan na Gael Hall (covid 19 restrictions permitting) and will be broadcast over Facebook. Any additional promotional events e.g. ticket giveaways will be advertised on our social media channels.
5. Clan na Gael reserves the right to cancel the draw or change the time and date of the draw for any technical or commercial reason. Any date changes will be communicated on our social media channels.
6. Clan na Gael reserves the right to amend these Terms and Conditions at any time throughout the competition.
7. Clan na Gael reserves the right to add additional bonus prizes where necessary. Each entrant may qualify for additional prizes if and when announced.
8. In order for the draw to proceed a minimum of 250 tickets must be sold.
9. There is a maximum of 600 tickets available.
10. There is no limit to the amount of tickets an individual can purchase.
11. Tickets can be purchased online on Clubforce or physically from Clan na Gael ticket sellers.
12. The draw is open to club members and non club members alike. Members of Clan na Gael and it's committee are permitted to enter the draw.
13. Participation in the draw implies full acceptance of these Terms and Conditions. Failure to comply with the Terms and Conditions shall entail cancellation of the draw entry.
14. By participating, entrants agree that in the event of being selected as a winner, they may be asked to take part in reasonable publicity related to the draw, including the publication of their name, county, firm or company (if applicable) and any photographs.
15. These terms and conditions are governed by the laws of the Republic of Ireland.
16. The closing date of the draw is 24<sup>th</sup> December 2021.
